If the limited liability company has issued shares, enter the total number of shares of each class entitled to vote on the merger (e.g., Class A: 50 shares and Class B: 40 shares); or, If the limited liability company votes are based on a percentage of profits and losses, enter "100% of the membership."

It outlines the daily operations as well as what happens if a conflict arises or a member needs to leave the business (by choice or for other reasons). Member details, such as their duties and contributions, are also included in the agreement.
