A Denial of Paternity (DOP) is a legal form signed by a presumed father that states (under penalty of perjury) that the presumed father is not the child's genetic father. To be valid, the child's genetic father and mother must also sign an Acknowledgment of Paternity (AOP) and both the DOP and the AOP forms must be
